Proof of your identity. (Any of the following). Your valid national passport. National identity card. Home Office travel document. Home Office entitlement card.

All British citizenship fees must be paid in full at the time that you send your application to the home office. When you Pay your British Citizenship Fees If you do not pay these fees at the time of your application your application will be regarded as invalid and you will be charged a £25 administration fee.

If you are not able to fulfil this Good Character test, your British citizenship application will be denied. It is very important that you keep this in mind when applying for British citizenship.
