MILD TBI (CONCUSSION) SYMPTOMS AND DIAGNOSES A

mild TBI, otherwise known as a concussion, is caused by a blow or jolt to the head that disrupts the function of the brain. Not all blows or jolts to the head cause brain injury. In combat, concussions are usually caused by a bullet fragment, blast, fall, direct impact or motor vehicle crash.

An object that penetrates brain tissue, such as a bullet or shattered piece of skull, also can cause traumatic brain injury. Mild traumatic brain injury may affect your brain cells temporarily. More-serious traumatic brain injury can result in bruising, torn tissues, bleeding and other physical

Mild TBI Symptoms A traumatic brain injury (TBI) can be classified as mild if loss of consciousness and/or confusion and disorientation is shorter than 30 minutes. While MRI and CAT scans are often normal, the individual has cognitive problems such as headache, difficulty thinking, memory problems, attention deficits, mood swings and frustration.

Mild TBI Symptoms – Traumatic Brain Injury

The effects of a traumatic brain injury on an individual depends on a number of factors such as the type, location and severity of injury. Symptoms can be wide-ranging, from physical effects such as balance problems, headaches and dizziness to cognitive, emotional and behavioural effects such as memory problems, fatigue and anger.
